

Chapter 1: Hardware Setup

Getting to know your Notebook PC

Top View

NOTE: The keyboard's layout may vary per region or country. The top view may also vary in appearance depending on the Notebook PC model.





Camera indicator

The camera indicator lights up when the built-in camera is in use.



Camera

The built-in camera allows you to take pictures or record videos using your Notebook PC.



Microphone

The built-in microphone can be used for video conferencing, voice narrations, or simple audio recording.



Display panel

This high-definition display panel provides excellent viewing features for photos, videos, and other multimedia files on your Notebook PC.



Capital lock indicator

This indicator lights up when the capital lock function is activated. Using capital lock allows you to type capitalized letters (such as A, B, C) using your Notebook PC's keyboard.



Power button

Press the power button to turn your Notebook PC on or off. You can also use the power button to put your Notebook PC to sleep or hibernate mode and wake it up from sleep or hibernate mode.

In the event that your Notebook PC becomes unresponsive, press and hold the power button for about four (4) seconds until your Notebook PC shuts down.



Keyboard

The keyboard provides full-sized OWERTY keys with a comfortable travel depth for typing. It also enables you to use the function keys, allows guick access to Windows[®], and controls other multimedia functions

NOTE: The keyboard layout differs by model or territory.

Keyboard as numeric keypad

These set of keys toggles between their actual key functions and as numeric keys.

> **NOTE:** For more details, refer to the *Keyboard as numeric keypad* section in this manual



Fingerprint sensor

This built-in fingerprint sensor captures your fingerprint and uses it as biometric authentication for logging on to your Notebook PC's system and other programs inside Windows® 8.

> NOTE: For more details, refer to the ASUS Fingerprint section in this manual.



Touchpad

The touchpad allows the use of multi-gestures to navigate onscreen, providing an intuitive user experience. It also simulates the functions of a regular mouse.

> NOTE: For more details, refer to the Gestures for the touchpad section in this manual.


Bottom

WARNING!

- The bottom of the Notebook PC can get warm to hot while in use or while charging the battery pack.
- When working on your Notebook PC, do not place it on surfaces that can block the vents.

IMPORTANT! Battery time varies by usage and by the specifications for this Notebook PC. The battery pack cannot be disassembled.

NOTE: The bottom side may vary in appearance depending on model.





Air vents

The air vents allow cool air to enter and warm air to exit the Notebook PC

> WARNING! Ensure that paper, books, clothing, cables, or other objects do not block any of the air yents or else overheating may occur.



Spring battery lock

The spring battery lock automatically locks the battery pack in place once it is inserted into the battery slot.

> **IMPORTANT!** This lock should be held in an unlocked position when removing the battery pack.



3 Audio speakers


The built-in audio speaker allows you to hear audio straight from the Notebook PC. The audio features of this Notebook PC are software-controlled.



Battery pack

The battery pack is automatically charged when your Notebook PC is connected to a power source. When charged, the battery pack supplies power to your Notebook PC.

Right Side



Headphone output/microphone input combo jack port

This port allows you to connect your Notebook PC to amplified speakers or headphones. You can also use this port to connect your Notebook PC to an external microphone.

USB 3.0 port with USB Charger+

This USB 3.0 (Universal Serial Bus 3.0) port provides a transfer rate of up to 5 Gbit/s and is backward compatible to USB 2.0. The 4 icon indicates this port's USB Charger+ feature which allows you to quick-charge mobile devices.

NOTE: For more details, refer to the USB Charger+ section in this manual.

HDMI port

This port is for the HDMI (High-Definition Multimedia Interface) connector and is HDCP compliant for HD DVD, Blu-ray, and other protected content playback.



VGA port

This port allows you to connect your Notebook PC to a standard VGA-compatible device, such as monitors or projectors.



Power (DC) input port

Insert the bundled power adapter into this port to charge the battery pack and supply power to your Notebook PC.

WARNING! The adapter may become warm to hot while in use. Do not cover the adapter and keep it away from your body while it is connected to a power source.

IMPORTANT! Use only the bundled power adapter to charge the battery pack and supply power to your Notebook PC.

Left Side





Kensington[®] security slot

The Kensington[®] security slot allows you to secure your Notebook PC using Kensington[®] compatible Notebook PC security products.



LAN port

Insert the network cable into this port to connect to a local area network.



USB 2.0 ports

These USB (Universal Serial Bus) ports are compatible with USB 2.0 or USB 1.1 devices such as keyboards, pointing devices, flash disk drives, external HDDs, speakers, cameras and printers.



Memory card reader

This built-in memory card reader supports SD and MMC card formats.

Status indicators

The status indicators help identify the current hardware status of your Notebook PC.



Ω Power indicator

The power indicator lights up when the Notebook PC is turned on and blinks slowly when the Notebook PC is in sleep mode.

Two-color battery charge indicator

The two-color LED provides a visual indication of the battery's charge status. Refer to the following table for details:

Color	Status
Solid Green	The Notebook PC is plugged to a power source and the battery power is between 95% and 100%.
Solid Orange	The Notebook PC is plugged to a power source, charging its battery, and the battery power is less than 95%.
Blinking Orange	The Notebook PC is running on battery mode and the battery power is less than 10%.
Lights off	The Notebook PC is running on battery mode and the battery power is between 10% to 100%.

Drive activity indicator

This indicator lights up when your Notebook PC is accessing the internal storage drives.

(y) Bluetooth / Wireless indicator

This indicator lights up when your Notebook PC's wireless function (Bluetooth or Wi-Fi) is enabled.


Chapter 2: Using your Notebook PC

Getting started

NOTE: If your Notebook PC does not have its battery pack installed, use the following procedures for installation.

Install the battery pack.

Align and insert the battery pack into the Notebook PC's battery slot.




Charge your Notebook PC.

- A. Connect the AC power cord to the AC/DC adapter.
- B. Plug the AC power adapter into a 100V~240V power source.
- C. Connect the DC power connector into your Notebook PC's power (DC) input.



Charge the Notebook PC for **3 hours** before using it in battery mode for the first time.

NOTE: The power adapter may vary in appearance, depending on models and your region.



IMPORTANT!

Power adapter information:

- Input voltage: 100-240Vac
- Input frequency: 50-60Hz
- Rating output current: 3.42A (65W)
- Rating output voltage: 19V

IMPORTANT!


- Locate the input/output rating label on your Notebook PC and ensure that it matches the input/output rating information on your power adapter. Some Notebook PC models may have multiple rating output currents based on the available SKU.
- Ensure that your Notebook PC is connected to the power adapter before turning it on for the first time. We strongly recommend that you use a grounded wall socket while using your Notebook PC on power adapter mode.
- The socket outlet must be easily accessible and near your Notebook PC.
- To disconnect your Notebook PC from its main power supply, unplug your Notebook PC from the power socket.



Gestures for the touchpad

Gestures allow you to launch programs and access the settings of your Notebook PC. Refer to the following illustrations when using hand gestures on your touchpad.


Moving the pointer

You can tap or click anywhere on the touchpad to activate its pointer, then slide your finger on the touchpad to move the pointer onscreen.


Slide horizontally



Slide vertically






- In the Start screen, click an app to launch it.

- In the Start screen, tap an app to launch it.
- In Desktop mode, double-tap an application to launch it.

Drag and drop



Double-tap an item, then slide the same finger without lifting it off the touchpad. To drop the item to its new location, lift your finger from the touchpad.

NOTE: The following edge gestures work only in Windows® 8.

Top edge swipe







Chapter 3: Working with Windows[®] 8

Starting for the first time

When you start your computer for the first time, a series of screens appear to guide you in configuring the basic settings of your Windows[®] 8 operating system.

To start your Notebook PC for the first time:

- 1. Press the power button on your Notebook PC. Wait for a few minutes until the setup screen appears.
- From the setup screen, pick a language to use on your Notebook PC.
- 3. Carefully read the License Terms. Tick I accept these license terms for Windows and this PC then click Accept.
- 4. Follow the onscreen instructions to configure the following basic items:
 - Personalize
 - Wireless
 - Settings
 - Sign in to your PC
- After configuring the basic items, the Windows®8 tutorial appears. Watch this to learn more about Windows®8 functionalities.

Windows[®] 8 lock screen

The Windows®8 lock screen may appear when your Notebook PC enters the Windows®8 operating system. To proceed, tap on the lock screen or press any key on your Notebook PC's keyboard.

Windows[®] UI

Windows® 8 comes with a tile-based user interface (UI) which allows you to organize and easily access Windows® apps from the Start screen. It also includes the following features that you can use while working on your Notebook PC.

Start screen

The Start screen appears after successfully signing in to your user account. It helps organize all the applications you need in just one place.



Windows[®] Apps

These are apps pinned on the Start screen and displayed on tiled-format for easy access.

NOTE: Some apps require signing in to your Microsoft account before they are fully launched.

Hotspots

Onscreen hotspots allow you to launch programs and access the settings of your Notebook PC. The functions in these hotspots can be activated using the touchpad.

Working with Windows[®] apps

Launching apps



Position your mouse pointer over the app then left-click or tap once to launch it.



Press twice then use the arrow keys to browse

through the apps. Press enter to launch an app.



Customizing apps

You can move, resize, unpin, or close apps from the Start screen using the following steps:

Double-tap on the app then drag and drop the app to a new location

Closing apps



Pinning more apps on the Start screen

You can pin more apps on the Start screen using your touchpad.

Charms bar

The charms bar is a toolbar that can be triggered on the right side of your screen. It consists of several charms that allow you to share applications and provide quick access for customizing the settings of your Notebook PC.

NOTE: When called out, the Charms bar initially appears as a set of white icons. The image above shows how the Charms bar looks like once activated.

This charm allows you to look for files, applications, or programs in your Notebook PC.

Using Snap

Use your Notebook PC's touchpad or keyboard to activate and use Snap.





Wi-Fi

Access emails, surf the Internet, and share applications via social networking sites using your Notebook PC's Wi-Fi connection.

IMPORTANT! The **Airplane mode** disables this feature. Ensure that **Airplane mode** is turned off before enabling the Wi-Fi connection of your Notebook PC.

NOTE: 5GHz is supported on selected models.

Enabling Wi-Fi

Activate Wi-Fi in your Notebook PC using the following steps on your touchpad.

- 1. Launch the **Charms bar**.
- 2. Tap 🔅 and tap 📩 II
- 3. Select an access point from the list of available Wi-Fi connections.



4. Tap **Connect** to start the network connection.

NOTE: You may be prompted to enter a security key to activate the Wi-Fi connection.

 If you want to enable sharing between your Notebook PC and other wireless-enabled systems, tap Yes, turn on sharing and connect to devices. Tap No, don't turn on sharing or connect to devices if you do not want to enable the sharing function.

Bluetooth

Use Bluetooth to facilitate wireless data transfers with other Bluetoothenabled devices.

IMPORTANT! The **Airplane mode** disables this feature. Ensure that **Airplane mode** is turned off before enabling the Bluetooth connection of your Notebook PC.

Pairing with other Bluetooth-enabled devices

You need to pair your Notebook PC with other Bluetooth-enabled devices to enable data transfers. To do this, use your touchpad as follows:

- 1. Launch the Charms bar.
- 2. Tap Settings then tap Change PC Settings.
- 3. Under **PC Settings**, select **Devices** then tap **Add a Device** to search for Bluetooth-enabled devices.



 Select a device from the list. Compare the passcode on your Notebook PC with the passcode sent to your chosen device. If they are the same, tap Yes to successfully pair your Notebook PC with the device.

NOTE: For some bluetooth-enabled devices, you may be prompted to key in the passcode of your Notebook PC.



Airplane mode

The **Airplane mode** disables wireless communication, allowing you to use your Notebook PC safely while in-flight.

- 12. Tap in the taskbar then tap the connection you just created.
- Type your user name and password then tap Connect to start connecting to the Internet.

Configuring a static IP network connection

- 1. Repeat steps 1 to 5 under *Configuring a dynamic IP/PPPoE network connection*.
- 2 Tap Use the following IP address.
- 3. Type the IP address, Subnet mask and Default gateway from your service provider.
- 4. If needed, you can also type the preferred DNS server address and alternate DNS server address then tap **OK**.

Turning your Notebook PC off

You can turn off your Notebook PC by doing either of the following procedures:



Putting your Notebook PC to sleep

To put your Notebook PC on Sleep mode, press the power button once.



You can also put your Notebook PC to sleep mode using Desktop mode. To do this, launch the desktop then press alt + f4 to launch the Shut Down window. Select **Sleep** from the drop-down list then select **OK**.

Chapter 4: ASUS apps

Featured ASUS Apps

Power4Gear Hybrid

Optimize the performance of your Notebook PC using the power saving modes in Power4Gear.

NOTE: Unplugging the Notebook PC from its power adapter automatically switches Power4Gear Hybrid to Battery Saving mode.

Launching Power4Gear Hybrid



Running System

This option allows you to enable either of the following power saving modes in your Notebook PC.

NOTE: By default, your Notebook PC is set to Performance mode.

Performance mode

Use this mode when doing high-performance activities like playing games or conducting business presentations using your Notebook PC.

Battery Saving mode

This mode extends your Notebook PC's battery life while plugged in to the power adapter or while running on battery power only.



power saving mode.

This option allows you to hide the desktop icons and turns the presentation mode on or off.

System in Sleep

This option allows you to enable or disable either of the following sleep modes:

Instant On

This mode is default-enabled in your Notebook PC. It allows the system to return to its last working state even after your Notebook PC has entered into sleep mode.



Move this slider to switch between Instant On or Long Standby Time.

Long Standby Time

This mode allows your Notebook PC's battery to last for up to sixty-nine (69) days or more. When enabled, the Notebook PC returns to its last working state in as fast as seven seconds, four hours after entering into deep sleep mode.



USB Charger+

USB Charger+ allows you to quick-charge devices using your Notebook PC's USB 3.0 charge port with the **4** icon.

WARNING: If your connected device overheats, remove it immediately.

Setting the quick-charge limit

By default, your Notebook PC can support quick-charging via the USB Charger+ port while on power adapter mode.

Using the USB Charger+ settings, you can set a quick-charge limit so you can continue quick-charging devices using the same port even while your Notebook PC is running on battery mode or turned off.

NOTE: Some Notebook PC models support quick-charging even while on sleep, hibernate, or shut down mode, depending on SKU.

- 1. From the taskbar on your Desktop, click \bigtriangleup .
- 2. Right-click on the 🗒 icon then click **Settings.**



3. Move the percentage slider to the left or to the right to set the limit for charging devices.



NOTE: The default limit is set to 40% but you can set the quick-charge limit from 20% to 99%.

4. Click **OK** to save and exit.

Trusted Platform Module (TPM)*

The TPM, or Trusted Platform Module, is a security hardware device on the system board that will hold computer-generated keys for encryption. It is a hardware-based solution that can help avoid attacks by hackers looking to capture passwords and encryption keys for sensitive data.

The security features provided by the TPM are internally supported by the following cryptographic capabilities of each TPM:

- hashing
- random number generation
- asymmetric key generation
- asymmetric encryption/decryption

Each individual TPM on each individual computer system has a unique signature initialized during the silicon manufacturing process that further enhances its trust or security effectiveness. Each individual TPM must have an Owner before it is useful as a security device.

TPM Applications

TPM is useful for any customer that is interested in providing an addition layer of security to the computer system. The TPM, when bundled with an optional security software package, can provide overall system security, file protection capabilities and protect against email/privacy concerns.

TPM helps provide security that can be stronger than that contained in the system BIOS, operating system, or any non-TPM application.

NOTE: The TPM is disabled byb default. Use BIOS to enable this feature.

Capture fingerprint biometrics on your Notebook PC's fingerprint sensor using the ASUS FingerPrint app. This app allows you to use fingerprint biometrics as user-authenticated access into your Notebook PC's system and applications.

Using this app, you can enable the following features:

- Swipe your finger over the fingerprint sensor to log on from boot up straight into the Windows® operating system without manually keying in passwords.
- Set up the boot key as backup access for your fingerprint biometrics.
- Import or back up other fingerprint biometrics you would like to use to log on to your Notebook PC and its system programs.



Chapter 5: Power-on Self Test (POST)

The Power-on Self Test (POST)

The Power-on Self Test (POST) is a series of software-controlled diagnostic tests that run when you turn on or restart your Notebook PC. The software that controls the POST is installed as a permanent part of the Notebook PC's architecture.

Using POST to access BIOS and Troubleshoot

During POST, you can access the BIOS settings or run troubleshooting options using the function keys of your Notebook PC. You may refer to the following information for more details.

BIOS

The Basic Input and Output System (BIOS) stores system hardware settings that are needed for system startup in the Notebook PC.

The default BIOS settings apply to most conditions of your Notebook PC. Do not change the default BIOS settings except in the following circumstances:

- An error message appears onscreen during system bootup and requests you to run the BIOS Setup.
- You have installed a new system component that requires further BIOS settings or updates.

WARNING: Using inappropriate BIOS settings may result to system instability or boot failure. We strongly recommend that you change the BIOS settings only with the help of a trained service personnel.

Accessing BIOS



Restart your Notebook PC then press $\left[m \right]^{2}$ during POST.

- Use ASUS Live Update to update ASUS-exclusive applications, drivers and utilities in your Notebook PC. Refer to the ASUS Tutor installed in your Notebook PC for more details.
- Use an anti-virus software to protect your data and keep this updated too.
- Unless absolutely necessary, refrain from using force shutdown to turn off your Notebook PC.
- Always backup your data and make it a point to create a backup data in an external storage drive.
- Refrain from using the Notebook PC at extremely high temperatures. If you are not going to use your Notebook PC for a long period of time (at least a month), we recommend that you take out the battery if the battery is removable.
- Disconnect all external devices and ensure you have the following items prior to resetting your Notebook PC:
 - Product key for your operating systems and other installed applications
 - Backup data
 - Log in ID and password
 - Internet connection information

Hardware FAQs

1. A black dot, or sometimes a colored dot, appears onscreen when I turn on the Notebook PC. What should I do?

Although these dots normally appear onscreen, they will not affect your system. If the incident continues and subsequently affects system performance, consult an authorized ASUS service center.

2. My display panel has an uneven color and brightness. How can I fix this?

The color and brightness of your display panel may be affected by the angle and current position of your Notebook PC. The brightness and color tone of your Notebook PC may also vary per model. You may use the function keys or the display settings in your operating system to adjust the appearance of your display panel.

3. How can I maximize my Notebook PC 's battery life?

You can try doing any of the following suggestions:

- Use Battery Mode under Power4Gear.
- Use the function keys to adjust the display brightness.
- Enable Battery Saving mode under Instant On.
- If you are not using any Wi-Fi connection, switch your system into **Airplane mode**.
- Disconnect unused USB devices.
- Close unused applications, especially those that take up too much system memory.

4. My battery LED indicator does not light up. What's wrong?

- Check whether the power adapter or battery pack is attached correctly. You may also disconnect the power adapter or battery pack, wait for a minute, then reconnect them again to the power outlet and Notebook PC.
- If the problem still exists, contact your local ASUS service center for assistance.

5. Why is my touchpad not working?

- Press f_n + $f_{2}^{f_2}$ to enable your touchpad.
- Check if ASUS Smart Gesture has been set to disable the touchpad when connecting an external pointing device.

6. When I play audio and video files, why can't I hear any sound from my Notebook PC's audio speakers?

You can try doing any of the following suggestions:

- Press $f_n + f_n^{\frac{1}{2}}$ to turn up the speaker volume.
- Check if your speakers were set to mute.
- Check if a headphone jack is connected to your Notebook
 PC and remove it.
- Unlock the I/O Interface Security in your system's BIOS. For more details, refer to the I/O Interface Security section in this manual.

7. What should I do if my Notebook PC's power adapter gets lost or my battery stops working?

Contact your local ASUS service center for assistance.

8. Why does audio still come out from my Notebook PC's audio speakers even if I already connected my headphone into the right jack port?

Go to Control Panel > Hardware and Sound then access Audio Manager to configure the settings.

9. My Notebook PC cannot do keystrokes correctly because my cursor keeps on moving. What should I do?

Make sure that nothing accidentally touches or presses on your touchpad while you type on the keyboard. You can also disable

your touchpad by pressing $\int f_n + \int_{\mathbb{R}^2} f^9$.

My Notebook PC's touchpad is not working. What should I 10. do?

You can try doing any of the following suggestions:

- Check if ASUS Smart Gesture is set to disable touchpad by . connecting an external pointing device to your Notebook PC. If ves, disable this function.
- Press f_n + $\overline{H}^{(q)}$
- Instead of showing letters, pressing the "U", "I", and "O" keys 11. on my keyboard displays numbers. How can I change this?

Press the $\left| \frac{num R}{scr k} \right|$ key or $\left| \frac{1}{shift \Phi} \right| + \left| \frac{num R}{scr k} \right|$ (on selected models) on

your Notebook PC to turn off this feature and use the said keys for inputting letters.

Software FAQs

1. When I turn on my Notebook PC, the power indicator lights up but not my drive activity indicator. System bootup does not happen as well. What can I do to fix this?

You can try doing any of the following suggestions:

- Force shutdown your Notebook PC by pressing the power button for more than four (4) seconds. Check if the power adapter and battery pack are inserted correctly then turn on your Notebook PC.
- If the problem still exists, contact your local ASUS service center for assistance.

2. What should I do when my screen displays this message: "Remove disks or other media. Press any key to restart."?

You can try doing any of the following suggestions:

- Remove all connected USB devices then restart your Notebook PC.
- Remove any optical discs that are left inside the optical drive then restart.
- If the problem still exists, your Notebook PC might have a memory storage problem. Contact your local ASUS service center for assistance.

3. My Notebook PC boots slower than usual and my operating system lags. How can I fix this?

Delete the applications you recently installed or were not included with your operating system package then restart your system.

4. My Notebook PC does not boot up. How can I fix this?

You can try doing any of the following suggestions:

- Remove all connected devices to your Notebook PC then restart your system.
- Press F9 upon startup. When your Notebook PC enters Troubleshooting, select Refresh or Reset your PC.
- If the problem still exists, contact your local ASUS service center for assistance.

5. Why can't my Notebook PC wake up from sleep or hibernate mode?

- You need to press the power button to resume your last working state.
- Your system might have completely used up its battery power. Connect the power adapter to your Notebook PC and connect to a power outlet then press the power button.

6. How can I boot to DOS using my USB drive or ODD?

Refer to the following steps:

- a. Restart your Notebook PC and enter BIOS by pressing **F2** on your keyboard.
- b. Go to Boot > Launch CSM > Enabled.
- c. Go to the **Security** menu then set **Secure Boot Control** to **Disabled.**
- d. Press F10 to save changes and exit BIOS.
- e. Press and hold **ESC** to launch boot menu when your Notebook PC restarts.



Overview

On 4th August 1998 the European Council Decision regarding the CTR 21 has been published in the Official Journal of the EC. The CTR 21 applies to all non voice terminal equipment with DTMF-dialling which is intended to be connected to the analogue PSTN (Public Switched Telephone Network).

CTR 21 (Common Technical Regulation) for the attachment requirements for connection to the analogue public switched telephone networks of terminal equipment (excluding terminal equipment supporting the voice telephony justified case service) in which network addressing, if provided, is by means of dual tone multifrequency signalling.

Network Compatibility Declaration

Statement to be made by the manufacturer to the Notified Body and the vendor: "This declaration will indicate the networks with which the equipment is designed to work and any notified networks with which the equipment may have interworking difficulties."

Non-Voice Equipment

Answering machines and loud-speaking telephones can be eligible as well as modems, fax machines, auto-dialers and alarm systems. Equipment in which the end-to-end quality of speech is controlled by regulations (e.g. handset telephones and in some countries also cordless telephones) is excluded.
